Bylaws No 351.

Passed 28th August 1875

A Bylaws to establish four roads in Qummur.

The Municipal Council of the Corporation of Qummur hereby enacts that the following Roads be established. Viz.

- I Commencing on the line between the 7th and 8th Concessions at a point northwesterly 19 and 15 links from the original post marking lots 31 and 32; thence N 50° W 7 chains and 17 links; thence N 73° 30' W 11 chains 89 links; thence N 59° 30' W 7 chains 49 links; thence N 82° W 3 chains 14 links; thence N 20° 15' W 8 chains 31 links; thence N 22° 30' E 3 chains 50 links; thence N 40° W 4 chains 55 links; thence W 3 chains 43 links; thence N 57° 15' W 6 chains 79 links to the edge of Stony Lake
- II Commencing on the line between the 8th and 9th Concession at a point 19 chains and 50 links northwesterly from the southern limit of the 26th lot; thence N 31° 20' W 13 chains; thence N 3° 15' W 6 chains 67 links; thence North 19° W 4 chains; thence N 1° 30' W 13 chains 31 links; thence N 11° 30' W 5 chains 77 links to the Northern limit of lot number 27 at 2 chains and 8 links easterly from Concession line; thence N 31° W 2 chains 90 links to Concession line at 5 chains northwesterly from southern limit of lot 28.
- III Commencing on the line between the 8th and 9th Concessions at a point northwesterly 15 chains and 58 links from the southern limit of lot number 21; thence N 38° 30' W 7 chains 36 links; thence N 67° W 3 chains; thence N 53° 15'

W 3 chains 98 links; thence N 20° W 6 chains and 3 links; thence N 45° W 6 chains 41 links; thence N 16° W 8 chains 21 links; thence N 10° 45' E 4 chains; thence N 27° 30' E 6 chains 58 links; thence N 8° W 4 chains; thence N 2° 30' E 7 chains; thence N 21° E 7 chains 73 links to Concession line northerly 14 chains and 90 links from the original post marking the Southern limit of lot 13.

Commencing on the line between the Sixth and Seventh Concessions, and at the Northern limit of the 29th lot, then northerly as follows 13° 15' W 15 chains 11 links; thence N 72° 30' W 18 chains; thence N 13° 15' W 4 chains more or less to the Stony Lake road; thence from the above commencing point southerly as follows, S 73° 15' E 16 chains 49 links along the said Concession line; thence S 5° W 3 chains 3 links; thence S 12° 30' W 3 chains 144 links; thence S 10° W 50 chains; thence S 30° W 9 chains 68 links; thence S 3° W 5 chains 74 links; thence S 32° W 32 chains 80 links; thence S 21° W 7 chains 34 links; thence S 42° W 7 chains 26 links; thence S 10° W 16 chains; thence S 41° W 24 chains 80 links; thence S 52° 30' W 3 chains 8 links; thence S 7° W 28 chains 74 links; thence S 45° W 26 chains; thence S 42° W 10 chains 6 links; thence S 56° 30' W 2 chains 80 links; thence S 2° 30' W 5 chains 13 links; thence S 46° W 10 chains 8 links; thence S 37° W 15 chains 30 links; thence S 48° W 6 chains 34 links; thence South 56° W 2 chains; thence S 50° 30' W 10 chains; thence S 58° 30' W 16 chains 64 links; thence S 42° W 4 chains 68 links; thence S 65° W 6 chains; thence N 23° W 3 chains 13 links to the line between the 3rd and 4th Concessions; thence northerly along said Concession line 3 chains 63 links to centre of new road and limit between lots 19 and 20; thence S 77° W 13 chains 18 links to Indian River; thence N 85° W 3 chains 16 links across the Indian River; thence S 88° W 3 chains 60 links to present travelled road leading to Warsaw.

All the foregoing lines of road to be 66 feet in width, and the marked and posted lines to be the centres thereof, and in accordance with plans and reports of John Reid P. E. S.
